Committee Reports

- Timberbarons by Geoff Perkins
 - Tryouts are coming up

 - Club continues to work on the Manasco fields for play in the future.
- Castle Rock Soccer Club by Erin Brunelle
 - No current season
 - New rep for Coaches Liaison Committee-Stacy Sundberg
 - Erin to get her contact info to Lorna to be added to committee list
- Longview Soccer Club by Gary Bennett
 - Season going well
 - Issue with a parent at a U9 game who was unhappy with amount of time her child was playing in a game. Gary contacted parent and will be contacting coach.

- Issue with a BU12 coach who was unhappy with lack of calls from a ref. Coach came onto field. Gary will contact coach by end of week to resolve issue.
- Longview Soccer Club is holding soccer camp this summer, July 15-July 18.
- Referees by Jacob Allen
 - About 3 weeks into season and games have been mostly covered
 - Schedule continues to be a work in progress.
 - In a game on 4/27, player on Kelso U12 team was hit in face and blacked out. Player was put back into game after short rest. Concussion protocol was not followed. Mindy (from Castle Rock board) will talk to coach (she was witness to event). Jacob will talk to ref. Discussed importance of following concussion protocol.
- Coaches Liaison Committee by Gary Bennett
 - Coaches Manual is finished. Gary to review before it is sent to clubs.

New Business

Discussion regarding allowing Timber Baron players being allowed to play spring rec league if their Timber Baron team is not playing in the spring season. This would apply only to the U13 and up age divisions.

Motion made by Geoff for CYSA to allow up to 3 Timber Barons players who have been released from their contracts to play on a rec team during spring season if space allows on the rec roster for ages U13 and above.

Trieste seconded.

Motion made by Trieste for CYSA to allow U10 division be reffed by microrefs as U10 has the same field/rules as U9.

Lorna seconded.

There have been some U6/U7 coaches who are spending a lot of time on the field, causing the games to be delayed. While U6/U7 coaches are allowed to come onto the field to coach, it should be done quickly and in a way as to not interrupt the flow of the game. This needs to be emphasized at the coaches' meetings.

Discussed need for rules sheets divided by age groupings. Erin will check what she has and send to Lorna for review/discussion at next Ops. Meeting.

Registration fees for the fall will be changing. CYSA felt that Longview & Kelso fees should be the same. It was suggested the following:

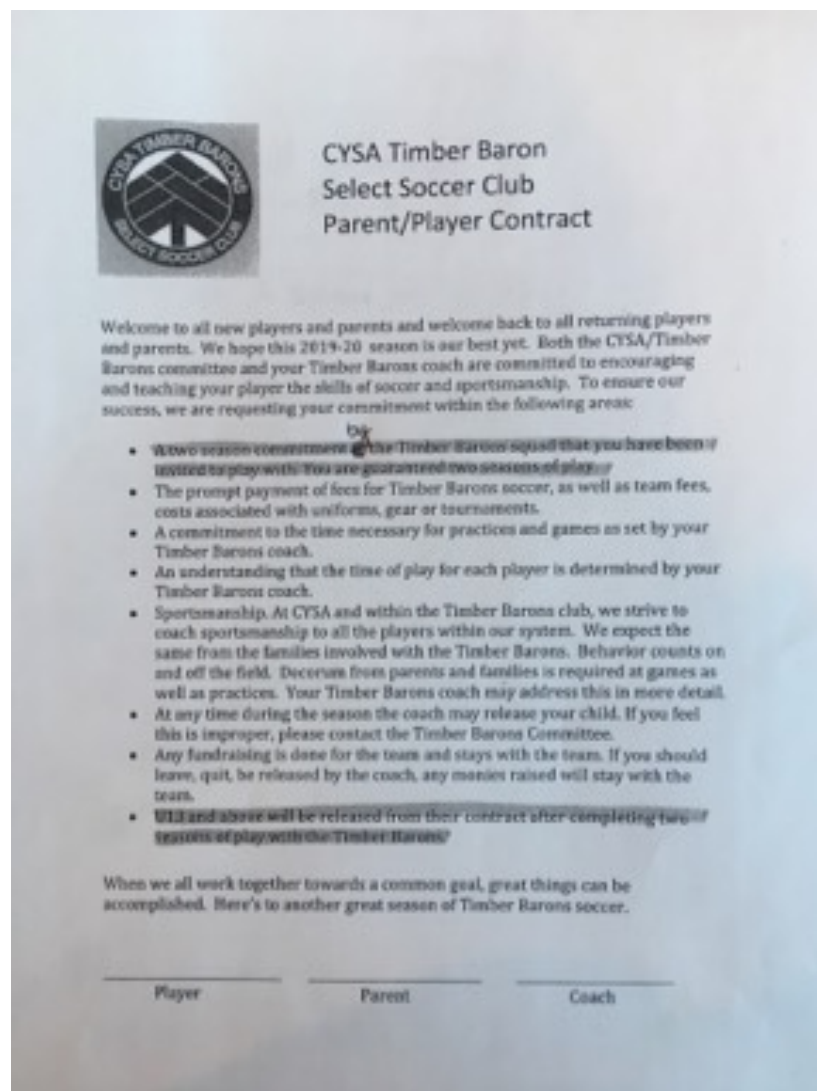
U6-U8 \$65
