Meeting called to order at 6:33pm

Registrars Comments and Reminders:

- Always list head coach and assistant coach on team folder as well as city (LV, KE, KA)
- Okay to move "Team A" when moving to CYSA, let Nicole know ASAP once a coach has been registered for that team.
- Any coach changes before or after season starts, must let Nicole know ASAP.
- Double check ages and gender of players registered.
- Double check League code (Spring-Rec for this season)
- Double check for all "CC", concussion compliance before official rosters are created.
- All player transfers between clubs MUST be completed ON or BEFORE 2/25/16
- Clubs to submit list of head coaches for more than one team to schedulers by March 5th
- All team folders MUST be registered in CYSA folder ON or BEFORE 3/5
- Official Rosters will be completed at the same time as CYSA folders by 3/5.
- Moving players after March 5th, Must let Nicole/Jak know immediately. Rosters will need to be corrected with enw signatures and allow time for player card adjustments.
- Late player's cards request must be submitted in ONE list from each club (not ots of separate requests)
- Deadlines MUST BE MET to keep the process moving

Coaching info reviewed:

- All coaches must be cleared through Affinity and have submitted Sudden Cardiac Arrest Certificate in order to receive Official Roster.
- Clubs must turn on Team Bonzi immediately after coaches meeting.
- Medical Waivers will be available online through Team Bonzi. This should be noted at the Coaches meeting.

Team Roster Finalization:

-Play up requests- It was reviewed that previous approvals of play up requests do not need approval more than once. Everyone in agreement. If a child has played up 2 years he may not play down in his own bracket if his play up team is still available.

BU7-BU9 David Cook-Caraveo Kelso. Mom requested son to play up because he is extremely big for his age and she does not want him to hurt the other children. She also notes he is a good player. (Note: Proper play up request was not submitted by Kelso. A copy was made of Mom's hand written note without a signature) Request unanimously approved.

GU9-GU11 Jeaquel Cole Castle Rock. Player has played up already from U9-U10 . Mom would like player to play on U11 team since she is coaching this team. Request unanimously approved for this season only due to bracket changes next season.

BU9-BU11 Tyler Ross Castle Rock. Dad would like to play him up on his U11 team because he is the coach. Player has always practiced with his older brothers team. Request unanimously approved for this season only due to bracket changes next season.

Combining age Brackets:

The only brackets that will be combined this season is BU12-BU13. This will allow them to play locally. Everyone is in agreement that this is the best option.

Vancouver:

It was discussed that only Brackets with less than 4 teams would go to Vancouver. Each bracket was discussed individually based on numbers. Those agreed upon by the committee to go to Vancouver are: BU14 , GU13 and GU14. We have enough teams for the other brackets to remain local.

Clubs provided total number of teams per each age bracket. If there are ANY changes after this meeting, you must let NICOLE know ASAP.

Player transfers were discussed amongst registrars....several parents will be contacted to request player transfers to other clubs.

Team Sports admin meeting was scheduled for Tuesday, March 22nd at 6:30pm at Jak's work.
